PROGRAM OUTLINE AND DIRECTIONS TO Minitab, Inc.

This presentation is about the Quality and Statistical Process Tools commonly used for process improvement and control in a manufacturing environment. These tools help you to analyze complex data and identify and solve process-related problems for both normal and non-normal data including Pareto Charts, Control Charts (XBar, R, individual moving range, CUSUM, EWMA), Process Capability Analysis Tools, and Gage R&R.

From State College/Bellefonte: Take the Valley Vista Dr. exit from Rt. 322 West. At the light at the end of the ramp, go straight (crossing over Atherton St.). Follow Valley Vista Dr. for about 1 mile. At the stop sign, go straight onto Science Park Rd. At the first light, turn left onto Pine Hall Rd. Take the first left (you'll see the Minitab sign) into the parking lot.

From Danville, Bloomsburg, Lewisburg, Milton: Take I-80 West to exit #161. Follow Rt. 220 South toward State College. Merge with Rt. 322 West toward Philipsburg/Altoona. Take the Valley Vista Dr. exit. At the light at the end of the ramp, go straight (crossing over Atherton St.). Follow Valley Vista Dr. for about 1 mile. At the stop sign, go straight onto Science Park Rd. At the first light, turn left onto Pine Hall Rd. Take the first left (you'll see the Minitab sign) into the parking lot.

From Williamsport/Lock Haven: Follow Rt. 220 South toward State College. Merge with Rt. 322 West toward Philipsburg/Altoona. Take the Valley Vista Dr. exit. At the light at the end of the ramp, go straight (crossing over Atherton St.). Follow Valley Vista Dr. for about 1 mile. At the stop sign, go straight onto Science Park Rd. At the first light, turn left onto Pine Hall Rd. Take the first left (you'll see the Minitab sign) into the parking lot.
